



2010-2011 Tuition Schedule

- >All new students pay a one time, non-refundable New Student Fee of \$125 in addition to the non-refundable Registration Fee.

- >If a payment due date falls on a Saturday, Sunday, or holiday, the following business day is the due date.
- >A late fee of \$40 will be charged to your account for any payment received after the due date. The fee will be charged to your account each month until it is current.
- >There is a charge for checks/drafts returned by the bank.
- >Any changes made to your Payment Plan on or after June 2, 2010 will result in a \$50 fee per student.
- >Student accident insurance is offered at the beginning of the school year at an additional cost.
