Tuition Information

Tuition is set up to provide your child with an inclusive educational experience. Tuition at each grade level includes fees covering: School Supplies, School Bag (EC), Spirit Shirt (EC), Yearbook, Field Day T-Shirt, Field Day Lunch (GS), Textbooks and Novels, Art Supplies, Field Trip Expenses, Technology Infrastructure and Student Use of Technology Equipment, Supplemental Student Accident Insurance, CMDS Parent Association Membership and several event costs, Out of Town Field Trips (4th-6th).

⁻All new students pay a one time, non-refundable \$125 New Student Fee (billed in August).

⁻The Tuition Refund Plan is optional for Plan 1 and can be purchased for 1.15% of the tuition. Please refer to the TRP brochure for more information.

⁻A late fee of \$55 will be charged to your account for any payments received after the due date.

⁻There is a charge for checks/drafts returned by the bank.

⁻Payment Plan changes may be made until June 1, 2024. After that date, the only plan changes allowed are Plan 1 to Plan 2 or 3, and Plan 2 to Plan 3 and a \$50 fee will be assessed.
